

Advertising and marketing services

An entrepreneur intention is headed for ad demand satisfaction.

The main idea for starting this business is the lack of modern technology for ad creation and promotion our regional market.

Our business intention is to place LED screens in the city of Lučenec.

One of the screens would be placed on a private house near a chain store Lidl where there is a big movement of people.

We're planning to put the 2nd screen in the Square of Republic in front of the shopping centre Galéria on the building of District Office.

We will place the 3rd screen on the reconstructed building of railway station in Lučenec.

Our next intention is constructing of portable billboards that would be placed in the town. We would offer them for rent to different companies. The 1st billboard would be placed on the exit road from Lučenec to Vidiná, the 2nd would be next to the Kaufland supermarket and the 3rd one on the exit road from Lučenec to Fil'akovo, next to the Billa supermarket.



Other than renting ad screens and spaces, our company will produce promotional items – business cards, calendars, pens, flyers, vouchers, T-shirts with prints, keychains, bags, car stickers, stickers for shop windows and mugs.

We also provide printing on clothes or other textiles depending on customer's order.

We will create tableaus, banners, ad boards and roll-ups based on customer needs.

We also provide customers with creating of a logo with or without registration.

6. The object of business

Providing of advertisements – will be a decisive object of our business activity. The main problem of today's ads is the lack of technical equipment. We want to offer modern and high-quality ads for acceptable prices.

We would look for clients and companies through the business register, we would agree on personal meetings where we would like to acquaint our customers with our business intention. After accepting the offer, we would create the design of advertisement on computer and then after approval, we would record the ad to the LED screen.

A big advantage of this is that a client can change and adjust an advertisement according to his needs what isn't possible with stationary or poster advertising. The ad adjustment will be included in the price of provided service for a potential customer.

Our business project won't have a harmful **impact on the environment** because the electricity consumption of LED screens is low. If the LED screen breaks, the disposal of LED screen will be ensured by the supplier.

The place of business and our office will be on the address: Lúčna 4, 984 16 Lučenec. The technical equipment like a computer, a multifunctional copy machine, a mobile phone, furniture (wardrobes, tables, chairs) and necessary software will be placed in our office.

The LED screen no. 1 will be located on the address: Haličská road 516/47 – Dom farieb (The house of colours). We have a contract on the future contract with the property owner who agrees to install the LED screen located on his house. Rental rate is 50€ per month.

The LED screen no. 2 will be located in the square of the Republic in front of the shopping centre Galéria Lučenec on the District Office building. We have a contract on the future contract with the property owner (City Council of Lučenec) who agrees to install the LED screen located on the District Office building. Rental rate is 80€ per month.

The LED screen no. 3 will be located on the railway station building in Lučenec. We have a contract on the future contract with the property owner (the Railway company Slovakia) who agrees with the installation of the LED screen. Rental rate is 70€ per month.

The billboard no. 1 will be placed on the exit road from Lučenec to Vidiná. We have the contract on the future contract with the owner (Lučenec town) of the land where the billboard

will be placed in which he agrees with the installation of the billboard. Rental rate is $50 \in \text{per}$ month.

The billboard no. 2 will be placed near the supermarket Kaufland on the address: Duklianskych hrdinov 5779, 984 01 Lučenec. With the owner of the Kaufland company's land where the billboard will be placed, we have a contract on the future contract in which he agrees with the installation of the billboard. Rental rate is 50 € per month.

The billboard no. 3 will be placed on the exit road from Lučenec to Fil'akovo next to the supermarket Billa on the address: Fil'akovská road 4591, 984 01 Lučenec. With the owner (Lučenec town) of the land where the billboard will be placed, we have a contract on the future contract in which he agrees with the installation of the billboard. Rental rate is 50 € per month.

The printing on clothes will be done by means of a printer machine according to the customer's requirement, respectively we will help the customer with the design of print.

The graphic proposal and production of tableaus, advertisement boards, banners and roll-ups will be done according to customer's requirements.

The graphic processing of logo's proposal for the company with or without the registration.

7. The services we will provide

Based on the requirement of our customer, we will design a graphic offer of advertisement for LED screen which will displayed at specified time intervals.

We offer a rental of billboard surfaces in a town of Lučenec. We also provide customers with the design of billboards, their printing and their installation.

We arrange graphic designs for printing of promotional items, such as clothes, textiles, key chains, pens, tableaus, banners, advertising flyers, brochures, etc.

We also make graphic design of a company's logo without registration, or we can alternatively provide a customer with the registration of the logo at the Industrial Property Office in Banská Bystrica.

9. Marketing strategies

When starting a business, our company has chosen so-called fast strategy of penetration, which means launching the product with low price and with strong emphasis on promotion. It's focused on acquiring a decisive market share.

The reasons of choosing this strategy:

- the market is big
- the market is unaware of the product existence
- most buyers are sensitive on the price of the product
- there is a strong potential competition
- effect of profit and effect of experience with production is significant

Marketing goals – within the first year, our goal is contractually commit at least 20 companies to have regular revenue from advertisements.

We will actively search for companies through phone calls or through personal meetings while explaining to our potential customers why the LED screen advertising or the billboard advertising is a big advantage for them.

An important precondition for a successful start of our business is technical equipment for creating of advertisements, active search for the customers and promotion.

To enhance our sales and profit, we will use 4 ways of advertising and marketing:

- 1. Direct marketing and selling
- 2. Internet marketing
- 3. Word of mouth advertising
- 4. Media advertising

Media advertising

We will advertise also in the local TV, local radio and local newspapers. We will distribute leaflets to people's mail boxes. We will use also billboards near big supermarkets, in the shopping center and on the exit roads from the town.

We will use <u>Internet marketing</u> to advertise, promote our products and services and drive ecommerce sales. We will use the strategy B2C (business to customers) and also B2B (business to business):

We will reach our customers and business partners through e-mail and e-shop.

Word of mouth advertising

We will try to make our customers satisfied, so they will share positive experiences with our products and services and recommend it to their friends, collegues and family members. It is very powerful way of advertising.

Direct marketing and selling

We will do marketing and sell our products and services <u>directly</u> to customers in our shop. We will built face-to-face relationships with our customers. Customers will receive our complimentary promotional products when they buy our products or use our services.

All our promotional products will have the logo of our company. We will have the promotional products such as different coulors of pens, mugs and beer glasses, T-shirts, mobile phone cases, key chains, USB keys and diaries.

10. Place, price, product, promotion

Place - purchasers – our current potential customers are any entrepreneurs or firms that want to promote their services or products.

Price – when creating a price of provided services, we will firstly take into account the amount of our costs, whether they are direct or indirect. The price of LED advertisement will depend on the length of advertisement and the number of plays a day.

Next, it is very important to take into account the competition prices. Directly in the town of Lučenec, where we will operate, there is only one company with similar object of business, but this company doesn't dispose with such a modern technology like us. At the same time, our strong side compared to our competitors is the location of LED displays and also better prices of services.

Product – providing of advertising and marketing services. Our benefit is the broad spectrum of provided advertising and marketing services.

Promotion - We want to address our potential customers personally, by phone, by e-shop, through social networks and also through leaflets.
